# God Has a Plan Not long ago, I received an e-mail which contained a story known as A Tale of Three Trees. I can recall reading

this story before, but in anticipation of the Feast of the Exaltation of the Holy Cross, September 14, 2008, I read it this time from a different perspective. The Feast of the Holy Cross celebrates the fact that a tree — the cross — became the instrument of our salvation. A Tale of Three Trees is a good reminder of the part that everyone plays in making the message of salvation known to others, especially in the ways that we use our God-given gifts and talents.

Once upon a mountaintop, three little trees stood and dreamed of what they wanted to become when they grew up. The first little tree looked up at the stars twinkling like diamonds above him. "I want to hold treasure," he said. "I

want to be covered with gold and filled with precious stones. I will be the most beautiful treasure chest in the world!"

The second little tree looked out at the small stream trickling by on its way to the ocean. "I want to be a strong sailing ship," he said. "I want to travel mighty waters and carry powerful kings. I will be the strongest ship in the world!"

The third little tree looked down into the valley below where busy men and busy women worked in a busy town. "I don't want to leave this mountaintop at all," she said. "I want to grow so tall that when people stop to look at me they will raise their eyes to heaven and think of God. I will be the tallest tree in the world!"

Years passed. The rains came, the sun shone, and the little trees grew tall. One day three woodcutters climbed the mountain.

The first woodcutter looked at the first tree and said, "This tree is beautiful. It is perfect for me." With a swoop of his shining axe, the first tree fell. "Now I shall be made into a beautiful chest," thought the first tree. "I shall hold wonderful treasure."

The second woodcutter looked at the second tree and said, "This tree is strong. It is perfect for me." With a swoop of his shining axe, the second tree fell. "Now I shall sail mighty waters," thought the second tree. "I shall be a strong ship fit for kings!"

The third tree felt her heart sink when the last woodcutter looked her way. She stood straight and tall and pointed bravely to heaven. But the woodcutter never even looked up. "Any kind of tree will do for me," he muttered. With a swoop of his shining axe, the third tree fell.

The first tree rejoiced when the woodcutter brought him to a carpenter's shop, but the busy carpenter was not thinking about treasure chests. Instead his work-worn hands fashioned the tree into a feed box for animals. The once-beautiful tree was not covered with gold or filled with treasure. He was

coated with sawdust and filled with hay for hungry farm animals.

The second tree smiled when the woodcutter took him to a shipyard, but no mighty sailing ships were being made that day. Instead the once-

strong tree was hammered and sawed into a simple fishing boat. Too small and too weak to sail an ocean or even a river, he was taken to a little lake. Every day he brought in loads of dead. smelly fish.

The third tree was confused when the woodcutter cut her into strong beams and left her in a lumberyard. "What happened?" the once-tall tree wondered. "All I ever wanted to do was stay on the mountaintop and point to God."

> Many, many days and nights passed. The three trees nearly forgot their dreams. But one night golden starlight poured over the first tree as a young woman placed her newborn baby in the feed box.

"I wish I could make a cradle for him," her husband whispered. The mother squeezed his hand and smiled as the starlight shone on the smooth and sturdy wood.

"This manger is beautiful," she said.

And suddenly the first tree knew he was holding the greatest treasure in the world.

One evening a tired traveler and his friends crowded into the old fishing boat. The traveler fell asleep as the second tree quietly sailed out into the lake. Soon a thrashing storm arose. The little tree shuddered. He knew he did not have the strength to carry so many passengers safely through the wind and rain. The tired man awakened. He stood up, stretched out his hand, and said, "Peace." The storm stopped as quickly as it had begun. And suddenly the second tree knew he was carrying the King of heaven and earth.

One Friday morning, the third tree was startled when her beams were yanked from the forgotten woodpile. She flinched as she was carried through an angry, jeering crowd. She shuddered when soldiers nailed a man's hands to her. She felt ugly and harsh and cruel. But on Sunday morning, when the sun rose and the earth trembled with joy beneath her, the third tree knew that God's love had changed everything.

Clearly, each one of the three trees in our tale had a particular goal in mind. The first wanted to be a treasure box; the second wanted to be an ocean going ship; the third wanted to remain just a tree. God had a different purpose in mind the first became a manger; the second became a small fishing boat; and the third became the cross. Each tree, and in different ways, ended up serving God. Each one found fulfillment by embracing the will of God. But, in order to truly embrace God's will, they each had to sacrifice their own will and dreams. continued on page 24

Kowalchick of St. Joseph's Parish in Hazleton, Pennsylvania, served as deacon. David Palcsey, a member of LPSCU Branch 76, White Oak, Pennsylvania, served as acolyte. Mr. Michael La Rocca, master of ceremonies to the Most Reverend Joseph Pepe, Bishop of Las Vegas, served as the master of ceremonies for the Convention Liturgy, along with diocesan acolytes.

Following the processional hymn, "Sing With All the Saints in Glory," Rev. Audet, representing Bishop Pepe, welcomed everyone to the Shrine and expressed his delight at the Convention Liturgy being celebrated there.

Reader at the Liturgy was LPSCU National Fraternal Activities Director Cecilia B. Gaughan. The Gospel reading was proclaimed by Deacon Cyril and an inspirational homily was offered by Bishop Adamec. The Presentation of the Gifts was offered by LPSCU National Officers: President Theresa Kluchinski, Vice President Anita Gregory, Secretary-Treasurer Mary Jo Savidge, and Chair of Trustees Mary Ann Ewasko.

During the Offertory, the congregation sang a favorite Slovak hymn, "O Maria Ruzencova," translated into English as "Mary of the Rosary." A post-Communion thanksgiving hymn was sung in honor of Saint Mary Magdalene, whose feast day was celebrated on July 22, the day of our Convention Liturgy.

Since Pope Benedict XVI dedicated the year 2008 to St. Paul the Apostle, all recited a Prayer for the Year of Saint Paul. The singing of the traditional recessional Slovak hymn, "Dusa Krestanska," concluded the beautiful service at the Shrine of the Most Blessed Redeemer.

# Joseph T. Senko Named 2008 LPSCU Fraternalist of the Year

The Ladies Pennsylvania Slovak Catholic Union is proud to announce that Joseph T. Senko of Branch 42, Pittsburgh, Pennsylvania, is our 2008 Fraternalist of the Year. Joe has been a member of the LPSCU for 6½ years. He was nominated for this award by Cecilia Sarocky, past president of the LPSCU and secretary of Branch 42.

As founder and director of the Western Pennsylvania Slovak Cultural

Association (of which the LPSCU is a sponsor), Joe has annually coordinated Slovak programs such as language, conversation, cooking, dancing, films, exhibits, and musical performances since the organization's inception 11 years ago. These cultural programs are untaken to encourage and facilitate youth and adults to work together. Many of the attendees at these events are LPSCU members.

Periodically, Joe submits articles relating to Slovak heritage and customs for publication in our fraternal magazine, *Zornicka*. He is dedicated to the cause of fraternalism and participates in LPSCU activities that are held in the Pittsburgh area.

Joe is very active in his community where he is instrumental in promoting cultural programs. He has initiated a project whereby \$10,000 worth of medical equipment and supplies will be sent to two nursing homes in Slovakia. He also promoted a drive to collect storybooks for children from ages 6 to 14 to be sent to Kosice, Slovakia, to help young Slovak children learn and practice the English language. Additionally, he held a drive for used computers that were sent to 45 schools in Slovakia.

When Slovak exchange students arrive in Pittsburgh to attend school, Joe takes the time to host them and make them feel welcome to the United States. He sponsored a "Day at the Baseball Park with the Pirates" which was an enjoyable social activity for youth and adults alike.

On April 5, 2008, the Fraternal Societies of Greater Pittsburgh, which comprises 21 fraternal benefit societies representing over 1.1 million members, honored Joe as its 2008 Fraternalist of the Year. As a Certified Public Accountant for 35 years, Joe has been recognized by his peers and has received many awards. He is currently associated with the Pittsburgh firm of McKeever Varga & Senko, CPAs.

Joe is the husband of Albina Senko, who is also a member of LPSCU Branch 42.

Truly, Joseph T. Senko has exhibited extraordinary acts of fraternalism in his Branch, and outstanding volunteer service in his community to qualify for the distinct honor of being named the 2008 LPSCU Fraternalist of the Year.

### WPSCA Business Award — Frederick N. Frank

Mr. Frank serves as a director of the Slovak American Enterprise Fund, having been appointed to the post by President Clinton in 1998. The fund's purpose is to support emerging small and medium sized businesses in Slovakia by operating as a private venture capital fund with U.S. tax dollars. He has been recognized for his service by receiving awards from President Bush in 2006 and from the Slovak Ambassador to the U.S. in 2007. The directors serve without pay.

### WPSCA Government Award — Gregory C. Fajt

Greg Fajt was appointed Chief of Staff to Governor Edward Rendell in 2007. As Chief of Staff, Fajt (pronounced "fight") serves as the top advisor to the Governor and manages the day-to-day activities of the executive branch of state government, including 18 cabinet agencies and the Governor's Office. Prior to that he served as Secretary of the Pennsylvania Department of Revenue from March 2003 through February 2007. He also served as State Representative for the 42nd District in Allegheny County from 1991 to 1996. Greg is a resident of Mount Lebanon for the past 25 years. His paternal grandparents both came from Slovakia at the turn of the century.

### WPSCA Religion Award — Bishop David A. Zubik

The Most Reverend David A. Zubik, Bishop of Pittsburgh, is a native of Sewickley, Pennsylvania. He attended St. Paul Seminary in Pittsburgh. He received his undergraduate degree from Duquesne University in 1971 and a degree in theology from St. Mary Seminary and University in Baltimore, Maryland in 1975. He also earned a master's degree at Duquesne in 1992. Bishop Zubik was consecrated a bishop in 1997, and was appointed auxiliary bishop to the Diocese of Pittsburgh. In 2003, Pope John Paul II, named the Most Reverend David A.

Zubik as the Eleventh Bishop of the Diocese of Green Bay. On July 18, 2007, he was named Bishop of Pittsburgh. Both of Bishop Zubik's maternal grandparents were born in Slovakia.

### WPSCA Lifetime Achievement Award — David G. Blazek

Dave, a resident of Peters Township, Pennsylvania, is well known throughout the fraternal benefit system. His career with fraternal societies began in 1986 when he was elected to the National Slovak Society Board of Directors. He became president of the organization in 1993 and he has held this position for the past 15 years. Under his leadership, the National Slovak Society has more than quadrupled its assets. In addition to Dave's leadership role with the NSS, both the Pennsylvania Fraternal Congress and the New Jersey Fraternal Congress have elected him to the offices of director, vice president, and president. He has also served in several key positions with the National Fraternal Congress of America. Locally, Dave has served as the president of the Fraternal Societies of Greater Pittsburgh.

### WPSCA Heritage Award — Rudy & Sue Ondrejco

The Pittsburgh Slovakians folk dance group was formed in 1956 by Roman Niznik. Rudy and Sue Ondrejco succeeded him in 1977. Between the junior and senior group, they have 40 dancers. They perform approximately 20 times a year in the Pittsburgh area. Over the years, they have performed at the Slovak Embassy in Washington, D.C., as well as many cities in Slovakia. Rudy, Sue, and all four of their daughters were dancers in the group. Rudy and Sue Ondrejco began hosting the Western Pennsylvania Slovak Radio Hour in 1979. Their radio listeners were within a 100-mile radius until they began broadcasting on the internet. Now they have listeners scattered throughout the U.S. and the entire world. The program, which is broadcast every Sunday from 3:00-4:00 p.m. on WPIT (89.3 AM), plays Slovak music for its listeners as well as updating news from Slovakia.





# **Dear Junior Members**,

Every year on the Sunday nearest the feast of St. Francis of Assisi, which is October 4th, Catholics and other Christian churches around the world host services where animals are blessed. These services are a powerful way to celebrate St. Francis's compassion for all living creatures. The Catholic Church honors St. Francis as the patron saint of animals and the environment.

St. Francis, whose given name was Giovanni Francesco Bernardone, was born at Assisi in Umbria in 1181 or 1182. His father was a prosperous cloth merchant who expected Francis to follow him is his trade. A privileged and carefree young man, Francis in 1201 joined a military expedition attacking Perugia, and was taken prisoner. It is suspected that his yearlong captivity began to turn his thoughts to more serious pursuits,

including religious ones. After his release, Francis resumed his carefree life, but more and more he spent time alone, seeking God's enlightenment. After a pilgrimage to Rome, Francis had a vision in which he felt that God called him to his service. Francis interpreted his vision as a request to repair the crumbling Church of San Damiano just outside Assisi, and so he sold his horse and other possessions to assist the priest in that task.

As Francis gradually left his friends and privileged life behind, choosing instead to help the poor and forgotten, his father became increasingly angry and embarrassed by his son's behavior. In the end, Francis renounced his father and gave up all his rights and possessions, choosing instead to live as a beggar and restoring several ruined churches in the Assisi area.

Later Francis felt himself called to preach. As his following grew, he received approval from Pope Innocent III

to form a brotherhood, which he called the Friars Minor. Although choosing not to be ordained as a priest (in keeping with his simple life), Francis was ordained a deacon, allowing him to read the Gospels in the church. St. Francis's impact on religious life has been enormous. No saint has affected so many in such profound ways as the gentle Saint of Assisi. Although born to wealth, he devoted his life to poverty and concern for the poor and the sick, and delighted in God's work as was revealed in nature. It is little wonder that he is one of the best-loved saints.

Have you ever been in Mexico around Easter? At this time the Blessing of the Animals is celebrated in a quaint and beautiful way. The people of Mexico prepare their animals and pets for this great event by adorning them with flowers and ribbons. Children and

grown-ups dress in their finest clothes and assemble in the town square. When the church bells begin to ring the people form a procession with their animals and head to church. You will see cows decorated with roses. Goats, lambs, rabbits, roosters, cats, dogs, horses, burros, birds - any animal you can think of – all proceeding down the narrow streets. Musicians line the way and play soft music as the procession passes by. The padre is on the church steps and blesses the animals one by one as they pass by him. As he sprinkles Holy Water on each he says these words: "Bless, O Lord, these animals so all will be well with them." It is an event much anticipated every year.

On a local level, it should be noted that our Honorary Chaplain, Msgr. Francis Beeda, also blesses the animals on the Sunday closest to St. Francis's October 4th Feast Day. This custom takes place at his parish, St. Joseph's in Hazleton, Pennsylvania. Many Catholic and non-Catholic parishes have adopted this custom. Because October is also the month dedicated to the "Respect for Life," by getting their animals blessed, children learn to respect their pets as a gift from God.

# A is for Apple

We all love apples but how much do we know about this favorite fall fruit? Here are some interesting facts.

• 7,500 varieties of apples are grown throughout the world, with some 2,500 varieties grown in the United States. The top apple producing states are Washington, New



- York, Michigan, Pennsylvania, California and Virginia.
- The crabapple is the only apple native to North America.
- The pilgrims planted the first U.S. apple trees in the Massachusetts Bay Colony.
- Have you ever bobbed for apples at a Halloween party? Ripe apples are made up of 25% air. That is why they float.
- Apple varieties range in size from just larger than a cherry to as large as a grapefruit. The world's largest apple picked weighed 3 pounds.

- Apples ripen 6 to 10 times faster at room temperature than when they are refrigerated.
- It takes the energy from 50 leaves to produce one apple.

# **Kids in the Kitchen**

### AFTER SCHOOL APPLE SNACK


Here's an easy-to-prepare, nutritious snack made with apples, peanut butter, and honey sandwiched between graham crackers.

You'll need:

- 2 Red Delicious apples
- Lemon juice
- <sup>1</sup>/<sub>2</sub> cup chunky peanut butter
- 2 tablespoons honey
- 1/2 teaspoon cinnamon
- 6 whole graham crackers

Core apples and cut each in half; cut each half into 3 wedges to make a total of 12. Dip wedges in lemon juice to prevent browning and place in a single layer on microwave-safe plate or baking dish. Cover loosely with waxed paper and microwave on high (100 percent) 3½ to 4 minutes or until apples are tender and hold their shape. (If microwave does not have carousel, rotate dish halfway through cooking.) Drain apples on paper towels.

In a small bowl, combine peanut butter, honey, and cinnamon. Snap graham crackers in half to make 12 square crackers. Spread a layer of peanut butter mixture on each of six square crackers; top each with 2 apple wedges. Top with remaining graham cracker squares to make a tasty apple sandwich.

# Cooking Corner

### YUMMY CHOCOLATE CAKE

½ cup (1 stick) unsalted butter4 oz. unsweetened chocolate, broken up2½ cups flour2¼ cups sugar1 cup cocoa powder2 tsp. baking soda½ tsp. baking powder1½ tsp. salt1½ cups sour cream3 eggs1 cup water2 tsp. vanilla extract

Heat oven to 350 degrees. Grease and flour three 9-inch round cake pans. In a glass bowl, melt butter and chocolate together in microwave on High until melted and smooth, 1 to 1½ minutes, stirring halfway through. Set aside. On low speed, mix flour, sugar, cocoa, baking soda, baking powder, and salt in a large bowl until blended. Add sour cream, eggs, 1 cup water, chocolate mixture, and vanilla; beat 30 seconds on low, until dry ingredients are moistened. Increasing to medium, beat 2 minutes. Pour into prepared pans. Bake at 350 degrees for 40 minutes or until cake springs back when pressed. Cool layers in pans on rack 10 minutes. Remove cakes to rack to cool.

### **Frosting**

4 oz. unsweetened chocolate, broken up

- <sup>1</sup>/<sub>2</sub> cup solid vegetable shortening
- <sup>1</sup>/<sub>2</sub> cup (1 stick) butter, softened
- <sup>1</sup>/<sub>3</sub> cup milk <sup>1</sup>/<sub>4</sub> tsp. salt

¼ cup sour cream2 tsp. vanilla extract1 box (1 lb.)confectioners' sugar

<sup>1</sup>/<sub>2</sub> cup cocoa powder

In a small glass bowl, melt chocolate in microwave on High for 1 minute. Stir until smooth. Set aside. Melt shortening, butter, sour cream, milk, vanilla, salt, 1 cup of sugar, and the cocoa powder in a medium-size bowl

until creamy. Gradually beat in remaining sugar and melted chocolate until thick and smooth. Place a cake layer on a pedestal. Spread with about <sup>2</sup>/<sub>3</sub> cup frosting. Top with second layer; spread with about <sup>2</sup>/<sub>3</sub> cup frosting. Top with remaining layer. Frost top and sides, swirling decoratively. Garnish with chocolate curls.
