## Spiritual Advisor's Message

## "Let him easter in us."

Recently, I had the privilege of concelebrating a Liturgy of Christian Burial for a very faithful and dedicated parishioner and member of the pastoral staff of the church where I currently reside, Our Lady of the Snows Parish, Clarks Summit, Pennsylvania. During his homily, the pastor of the parish, Monsignor James McGarry, quoted from "The Wreck of the *Deutschland*," a poem by the Jesuit poet, Gerard Manley Hopkins. The poem is about a tragedy which occurred in 1875, namely, the wreck of an iron passenger steamship, the *Deutschland*.

First, allow me to share a bit of history about this maritime tragedy. The *Deutschland* was constructed in 1866 by Caird & Company, Greenock, Scotland. Built as an emigrant passenger ship, the *Deutschland*'s maiden voyage was made on October 14, 1866, from Bremen, Germany, to New York via Southampton. The *Deutschland* sailed from Bremerhaven on December 4, 1875, commanded by Captain Edouard

Brickenstein, with emigrants bound for New York with a stop in Southampton, England. Weather conditions were very bad, and the ship had no clear idea of her position until, at 5:00 a.m. on December 5th, the ship ran aground in a blizzard on the Kentish Knock, a shoal

(sandbank) 25 miles off Harwich. At the time, the ship was 30 miles off course.

An attempt to go astern was made but failed when the stress fractured the *Deutschland*'s screw. The vessel began to take on water and as the tide rose, she failed to lift off the shoal as had been expected. The sea began to break over her and the wind rose to gale force. By 10:00 a.m. the next morning, the order had been given to abandon ship, and the crew and passengers panicked. While distress rockets were fired and numerous ships passed by, none took any notice.

One boat was launched from the distressed ship, but was swamped. A second boat with the quartermaster, a sailor, and a passenger aboard, eventually drifted ashore on the Isle of Sheppey the next day, with only the quartermaster left alive. This alerted people to the accident, and help eventually reached the wreck in the form of the steam paddle tug *Liverpool* which reached the *Deutschland* on December 7th; 135 persons were saved out of a total of 213.

Among the victims were five Franciscan nuns from Salzkotten, Westphalia, who had been emigrating to escape the anti-Catholic Falk Laws. These laws gave rise to a great struggle between the Catholic Church and the German government, beginning in 1873. The five nuns were buried in St. Patrick's Cemetery in Leytonstone, London, and their deaths are commemorated every year in a memorial service held on December 6th by the Wheaton Franciscan Sisters of Wheaton, Illinois — the destination of the five Sisters. The young nuns sacrificed their own lives so that others might be rescued. According to one account, the nuns remained below

deck as the ship sank. As the water rose around them, they clasped their hands together and were heard praying, "O Christ, O Christ, come quickly!" It was the deaths of these good nuns that inspired Gerard

Manley Hopkins to compose his poem, "The Wreck of the Deutschland." Hopkins saw in their deaths a parallel to the suffering of Christ.

During his homily, Monsignor McGarry quoted from the final stanza of Hopkins' poem:

Dame, at our door

Drowned, and among our shoals,

Remember us in the roads, the heaven-haven of the Reward:

Our King back, oh, upon English souls!

Let him easter in us, be a dayspring to the dimness of

us, be a crimson-cresseted east,

More brightening her, rare-

dear Britain, as his reign rolls, Pride, rose, prince, hero of

us, high-priest,

Our hearts' charity's hearth's fire, our thoughts' chivalry's throng's Lord.


I was very much taken by that particular line, "Let him easter in us." No, it is not a spelling error that the "e" of "easter" is lower-case. In the line of this poem, the word "easter" is actually a nautical term. It means steering a ship toward the east, into the light. Also, as it is used in this line, the word "easter" is used as a verb, an action word.

As we reflect upon the great feast of Easter, which is fast-approaching, this line reminds us that Easter may be used as a noun, a word that denotes a day when we rejoice in the reality of God's redemptive love that comes to us through the Resurrection of Jesus. But, given the usage of the nautical term "easter" in Hopkins' poem, we are also reminded that Easter may be used a verb: Easter is something we **think**, something we **feel**, and something we **do**.

Throughout our lives, we are challenged to steer towards the light, trying to navigate through the many difficulties that become part of our life's voyage. Easter, for us, is meant to be a way of living, a way of loving, a way of seeing, of hearing and understanding. As Christians, we are called to **live** Easter in every act of kindness, generosity and compassion. The nuns that died on the *Deutschland* were headed to America to serve God's people through the ministry of teaching. As true imitators of Jesus, they were willing to sacrifice their lives for others. They died so that others might be able to live. This is truly the mystery of the Easter or Paschal celebration.


As we pray during the Eucharistic Prayer of the Liturgy, "Though his nature was divine, he [Jesus] stripped himself of glory and by shedding his blood on the cross, he brought

There was much hope among those who heard Jesus speak of a future that included forgiveness and eternal life. What disappointment and hopelessness they must have felt after the crucifixion! Finding the tomb empty only added to their confusion and despair. The whole scenario was difficult to understand in human terms.

Some attach significance to the fact that the cloth, which had covered Jesus' head (Jn 20:7), was neatly rolled

up aside from the larger crumpled cloth that had covered the rest of the body. The Evangelist thought it important enough to record it for us.

Tradition has it that if you would like to return to a home at which you had dinner, you should neatly fold your napkin after the meal. It appears that Jesus left such a sign, indicating that He had not left, as if to never return.

Jesus did return and wishes to return. There was and is a Resurrection.

Regardless of how empty and hopeless our lives may seem at times, there is within us something akin to a neatly-folded napkin, which was placed there on the day of our Baptism. Easter is a time to invite Jesus back into our lives, with the confidence that He has no intention of leaving us abandoned.

During this Easter Season, may you find peace within the turmoil of this life. Hold on to the Good News of Jesus Christ that includes the message of forgiveness, resurrection, and the promise of eternal life. May your very presence to others be a song that resounds with a continuous *Alleluia*!










## Celebrating Saint Casimir, Patron of Lithuania

The feast day of Saint Casimir, patron of Lithuania, is celebrated on March 4, which is the date of his death. Thousands of pilgrims from various Lithuanian cities and villages attend Mass at Vilnius Cathedral on that date to observe Saint Casimir's feast day.

In honor of Saint Casimir, a traditional three-day, outdoor fair known as "Kaziuko muge" takes place over the weekend nearest to his actual feast day. The fair attracts thousands of visitors to Vilnius, the capital of Lithuania. A wide range of handcrafted goods are sold in the city's marketplaces, squares, and streets. The best weavers, blacksmiths, potters, and other craftsmen attend the fair, which is further enlivened by many musicians and dancers.

The fair's trademarks are traditional, lily-shaped palms called "verbos," which are made from colored dried flowers and herbs that are braided together into typical Lithuanian designs and tied to short sticks. The verbos are taken to church on Palm Sunday and then used for decorations in the home. The shape of Vilnius' palms originated from a lily with which Saint Casimir is traditionally portrayed.

Another typical product of the fair is what is known as "muginukas," a heart-shaped honey cookie which is decorated with colored sugar flowers, zig-zags, dots, and birds. Popular men's and women's names are written on the cookies. People buy and give them to loved ones. It is customary to take a cookie home for anyone who missed the fair.

For Lithuania, March 4th is not only Saint Casimir's feast day, but a national holiday as well. Saint Casimir died at the young age of 25. Young people of Lithuania were especially attracted to St. Casimir's youth and high regard for chastity. On June 11, 1948, Pope Pius XII named St. Casimir the special patron of all Lithuanian youth. The saint thus became the patron of youth not only within Lithuania, but in all countries where Lithuanian young people reside.

Fajt, chief of staff for Pennsylvania Governor Edward Rendell (Government Award); David G. Blazek, national president, National Slovak Society (Lifetime Achievement Award); and Most Reverend David A. Zubik, bishop, Diocese of Pittsburgh (Religion Award).

#### **SEAFOOD LASAGNA**

8 lasagna noodles 1 lg. chopped onion

(1 cup)

2 Tbsp. butter

8 oz. softened cream cheese 1/3 cup milk

12 oz. creamed cottage cheese

1 beaten egg

7½ oz. crabmeat, drained,

flaked & cartilage removed 2 tsp. crushed basil ½ cup sharp cheese, shredded

½ tsp. salt 1/8 tsp. pepper

22 oz. cream of mushroom

1/3 cup dry white wine

1 lb. shrimp, cooked and halved

1/4 cup Parmesan cheese

Cook noodles until tender. Place 4 noodles in 9x13x2-inch greased dish. Saute onions in butter. Blend in cream cheese. Stir in cottage cheese, egg, basil, salt and pepper. Spread one-half of cottage cheese mixture on top of noodles. Combine soup, milk, and wine. Stir in shrimp and crab. Spread one-half of seafood mixture over cottage cheese layer. Repeat layers of

noodles, cottage cheese, and seafood mixture. Sprinkle with Parmesan cheese. Bake, uncovered, at 350 degrees for 45 minutes. Top with shredded cheese. Bake 2 to 3 minutes more. Let stand 15 minutes before

serving.



### A Survivor's Story

Halloween can make one think of frightful things, and Halloween 1998 was all that and more for me, because on that day my doctor told me I had breast cancer. Unbelievably, the following year it was back — this time in the other breast! Even hearing the words "breast cancer" all these years later sends a chill down my spine. I am now a 10-year survivor, and I celebrate this milestone with more gratitude and elation than you could ever imagine.

I write this not only to celebrate my survivorship, but also to ask each of you to face the fact that breast cancer is real and, therefore, checkups should not be avoided. What should be avoided is pretending it cannot happen to you! And please remember: Even if your mammogram gives an all-clear diagnosis, you have the right to insist on an ultrasound of a growth you are concerned about. The doctor MUST honor vour request.

Every Mother's Day, the Susan G. Komen Race for the Cure for Breast Cancer takes place in Pittsburgh's Schenley Park. On Mother's Day 2008, the survivors numbered nearly 3,000 with approximately 40,000 supporters in the crowd. It was my 10th year of attendance at this emotional event. The most humbling moment was when two dozen white doves were released to circle overhead as the Pittsburgh Symphony played our "Song of the Survivors." I would like to think the doves were flying up to the heavens to thank and salute God for graciously sparing us!

To celebrate my 10-year anniversary, I sent 50 formal announcements, which picture me standing (encircled) in the crowd of over 40,000. It read: "To my God, my family, my doctors, my friends: On my ten year anniversary of survivorship, I want to thank you for your support, care and prayers during those dark and frightening days of diagnosis and treatment. Back then, ten years of survivorship was not something I thought I would see, but...I have Survived! I do Survive! I will Survive! I ask that you join me in saying a prayer of Thanksgiving. Thank you!"

I invite anyone who is facing breast cancer to please call me, because the most reassuring and comforting part of going through this disease is having the support of someone who has "been there, done that." And that's me!

### Dear Junior Members,

In March, we observe two great Feast Days. The first is the feast of St. Patrick, which we celebrate on March 17th. On this day many people — even those who are not Irish — wear something green in honor of this great saint. Green is also a reminder of the beautiful countryside of Ireland, which is so green that Ireland is often called the Emerald Isle. Green is also the color of the shamrock, a small cloverleaf plant with three leaves on each stem. It is the national symbol of Ireland.

In Ireland this feast day is both a holy day and an official holiday. Initially brought to Ireland as a slave by Irish raiders, the Roman Britain-born Patrick escaped after six years and returned to his family. Some years later, he would return as a missionary, seeking to convert the pagan Irish to Christianity. According to legend, he used the shamrock's three leaves to depict the mystery of the Holy Trinity by explaining that in the one God there are three divine persons, the Father, the Son and the Holy Spirit.

St. Patrick's Day is often celebrated with parades and great merriment. In Ireland it is sometimes referred to as the "Irish Mardi Gras." The St. Patrick's Day custom came to America in 1737 when The Charitable Irish Society of Boston organized what was the first Saint Patrick's Day Parade in the Colonies on March 17th.

Another great March feast is St. Joseph's Day, celebrated on the 19th. St. Joseph was a quiet, gentle man who receives very little mention in the Bible. He is always pictured as a kind,

### Did You Get Them All?

The popular U.S. state quarter program ended in November 2008 with the release of the Hawaii coin. The U.S. Mint began issuing the 50 commemorative state quarters in 1999 in the order in which each state joined the Union. Five coins were released per year at 10-week intervals.

This program was very well received by the public, creating a new generation of coin collectors. Roughly 147 million collectors gathered and saved these quarters. The program was intended to interest young people in U.S. history, geography, and coin collecting and by all accounts, it was a great success.

This was very lucrative for the U.S. Mint, generating \$3.5 billion in profit by the end of last year, not counting the special-issue sets.

The state quarters were minted at the Denver and Philadelphia mints. The quarter was chosen because of its broad circulation and for its size. Each state chose its own design for the back of its coin and it was felt this could best be depicted on a quarter rather than the smaller nickel, penny or dime.

The state quarter program was signed into affect on December 1, 1997, by then President Bill Clinton. The only other similar commemorative coin program that generated widespread public interest was the minting of the special Bicentennial quarters back in 1975 and 1976.

supportive man who greatly loved and cared for his family, the Virgin Mary and baby Jesus. He was a "tekton," meaning he was mechanically inclined and a skilled carpenter.

In Italy, St. Joseph's feast day is a holiday. It is a custom in Italy, and especially on the island of Sicily, to set up a "Saint Joseph's Table." All the townspeople load a large table with traditional Italian pasta dishes, along with special desserts. Three people are chosen to play the parts of Mary,

Joseph, and Jesus and they will welcome all to their table. The poor, the orphans, and the beggars are the traditional guests of honor. Many Italians still follow this custom in other parts of the world. Italians will wear red on St. Joseph's Day, just as the Irish wear green for St. Patrick's.

In Valencia, St. Joseph's Day is also a holiday. Residents have a week-long festival during which they have fireworks, parades, and dancing in the streets.

Huge cardboard animals and statues made out of papier-mâché decorate the streets and around midnight on the 19th, they are set ablaze, lighting up the city as they burn.

Then and now, Joseph, the Patron Saint of Workers, is relied on for his guidance, stability, and support. What better man is there for us to follow and honor to build the foundation of our family?

### Kids in the Kitchen

We are celebrating the season of Lent during which we will be eating many meatless meals. Here is a recipe for a special dish that you can eat during Lent (or any time). If you have never made pancakes before, please ask an adult to help.

#### **GOLD COIN PANCAKES**

These pancakes are very rich in flavor so you may not eat as many as usual. This recipe makes 6-8 pancakes but it can be doubled.

You will need:

2 eggs

1/3 cup of cottage cheese

½ cup of sifted flour

½ teaspoon baking soda

½ teaspoon salt

34 cup sour cream

Sift the flour, soda, and salt together. Set this aside until later. Crack the eggs and mix at low speed until they are thoroughly mixed. Add the cottage cheese and blend well at high speed. Now add the sour cream and mix on low until blended. Add the flour mixture and run the blender on low until everything is blended. Let the mixture stand for 10 minutes.

Fry the pancakes on a greased, medium-hot griddle or non-stick frying pan.



## Women's History Month

March is National Women's History Month. Here are a few of the American women we salute this month.

**Sally Ride** (1951- ) is an astronaut who became the

first American woman to travel to space. She urges science teachers to encourage girls to study science like she did. Because of her determination and perseverence, today more women are interested in science-related jobs and careers.

Rachel Carson (1907-1964) was a marine biologist and author. She was the first person to warn that pesticides (chemicals used to kill insects)



are harmful to man and the environment. Because of her work, many governments passed laws to limit the use of pesticides.

Clara Barton (1821-1912) started the American Red Cross. She was also involved in helping the victims of many disasters, such as floods and famines. Because of her work, many American lives today are saved by the efforts of the Red Cross.

**Dorothea Dix** (1802-1887) led the drive to build hospitals for the mentally ill in the United States. Before Dix's efforts, mentally ill individuals were often treated like criminals and locked in jails. Because of her dedication, the care of the mentally ill greatly improved.

**Sacagawea** (1788?-1812?) was a Shoshone Indian girl who accompanied Lewis and Clark on their 1804-1806 expedition to the Pacific Northwest. She served as an intrepreter and guide for the explorers. Because of Sacagawea's help, our government claimed the land Lewis and Clark explored for the United States.

When **Rosa Parks** (1913-2005), a black woman, refused to give up her seat to a white passenger on a bus in Alabama in 1955, she set off a chain of events that would give birth to the civil rights movement in the United States. Because of her efforts, blacks and other minorities won more rights than they ever had before.

peace to the world. Therefore he was exalted above all creation and became the source of eternal life to all who serve him." Despite the fact that they knew they were going to die, the nuns willing sacrificed their lives because they firmly believed that they would be welcomed into eternal life. Because Jesus conquered death, they knew that they would conquer death as well. We must believe the same.

During our Lenten journey of repentance and renewal, we focus on how, occasionally, we may veer off course from the life of faith we are called to live, thanks to our baptism. Our moments of prayer, our fasting or giving up of things that distract us and our acts of charity have helped to purify us so that we may be better prepared to celebrate Easter. It is important for us to remember that even though our Lenten penances may come to an end, the work of "staying on course" never ends. It takes us a lifetime to achieve that perfection that is required of those who follow Jesus. But, like the nuns on the *Deutschland*, we firmly believe that when our work is finally done, when our voyage is finally completed, we will be welcomed to shores of eternity — life with God forever in heaven.

Until that day comes, when we shall pass from this mortal life to the life that lasts forever, we continue to "let him easter in us." May we live our lives in the light of God's compassion and peace, his justice and forgiveness. Like the nuns on the <code>Deutschland</code> — like Jesus himself — may we be humble servants, embracing opportunities to die to self, so that others may fully live. In thanksgiving for the ultimate sacrifice Jesus made on our behalf, may we joyfully bear our crosses for one another. "Let him easter in us" that we may, at the end of our voyage, "easter" in him forever in heaven.
