Reverend Dianiska District Celebrates 70th Anniversari



Dianiska District of the Ladies Pennsylvania Slovak Catholic Union honored the District's 70th anniversary with a Mass of Celebration at St. Elizabeth Ann Seton Church, Hughes

Street, Swoyersville, Pennsylvania. A buffet dinner was served immediately following in the church hall.

The Reverend Dianiska District was founded in 1943 by Gabrielle Vavrek, national president of the LPSCU from 1931-1956. Mrs. Vavrek was a member of St. Stephen's Roman Catholic Church in Plymouth, Pennsylvania, and named the District after her pastor, Rev. Dr. Alexander Dianiska. Rev. Dr. Dianiska was born in Austria-Hungary on March 21, 1867, and immigrated in the United States in 1903. He was a very prominent Slovak priest who financially aided men and women to achieve an education. He was also one of the co-founders in establishing the congregation of the Sisters of Saints Cyril and Methodius in Danville, Pennsylvania.

The Reverend Dianiska District of the LPSCU is very proud of its Slovak heritage. We are grateful for the efforts of Mrs. Vavrek and Rev. Dr. Dianiska in forming our District.

The officers and members of the entire LPSCU congratulate the members of the Rev. Dianiska District in reaching this historic seven decade milestone. We wish them many more years of faithfully and lovingly serving their fellow members, the Church, and the community.

From April 14-26, 2013, I had the privilege of leading a Pilgrimage to both Rome, Italy, and Bratislava, Slovakia. At the urging of members of the Slovak Catholic Federation, this Pilgrimage was organized to celebrate some very significant anniversaries in the life of the Catholic Church.

With his Apostolic Letter of October 11, 2011, *Porta Fidei* (*The Door of Faith*), Pope Emeritus Benedict XVI declared that a "Year of Faith" would begin on October 11, 2012, and conclude on November 24, 2013. October 11, 2012, the first day of the Year of Faith, marked the fiftieth anniversary of the opening of the Second Vatican Council and also marked the twentieth anniversary of the promulgation of the *Catechism* of the Catholic Church. During the Year of Faith, Catholics have been asked to study and reflect on the documents of Vatican II and the *Catechism* so that they may deepen their knowledge of the faith.

The Year of Faith has been a "summons to an authentic and renewed conversion to the Lord, the One Savior of the world" (*Porta Fidei*, 6). In other words, the Year of Faith is an opportunity for Catholics to experience a conversion – to turn back to Jesus and enter

into a deeper relationship with him. The "door of faith" is opened at one's baptism, but during this year Catholics are called to open it again, walk through it and rediscover and renew their relationship with Christ and his Church.


While in Rome to celebrate the Year of Faith, our group had the opportunity to attend the weekly General Audience on Wednesday, April 17, presided over by His Holiness, Pope Francis. During the audience, Pope Francis continued a reflection on parts of the Profession of Faith (the Creed) we pray at Sunday Mass. The Holy Father reflected on the statement in the Creed where we say that Jesus "ascended into heaven and is seated at the right hand of the Father." Jesus' earthly life culminated with the Ascension, when he passed from this world to the Father and was raised to sit on his right. At the end of his Gospel, Saint Luke gives a very concise account of the event of the Ascension. Luke writes, "Jesus led

his disciples out as far as Bethany, and lifting up his hands he blessed them. While he blessed them, he parted from them, and was carried up into heaven. And they worshipped him, and returned to Jerusalem with great joy,



In concluding his teaching on this section of the Creed, Pope Francis said: "Dear brothers and sisters, the Ascension does not point to Jesus' absence, but tells us that he is alive in our midst in a new way. He is no longer in a specific place in the world as he was before the Ascension. He is now in the lordship of God, present in every space and time, close to each one of us. In our life we are never alone: we have the Advocate who awaits us, who defends us. We are never alone: the Crucified and Risen Lord guides us. We have with us a

multitude of brothers and sisters who, in silence and concealment, in their family life and at work, in their problems and hardships, in their joys and hopes, live faith daily and together with us bring the world the lordship of God's love, in the Risen Jesus Christ, ascended

into Heaven, our own Advocate who pleads for us."

Inspired by our Holy Father's words, which encouraged us to play our part in the mission of the Church, our group, later that same day, visited the Pontifical Slovak College (formerly the Slovak Institute) of Saints Cyril and Methodius. Under the direction of the late Bishop Andrew Grutka, the first bishop of the Diocese of Gary, Indiana, and with the assistance of the Slovak Catholic Federation, our Slovak Catholic fraternal benefit societies and other committed individuals, the Institute, which later was raised to the dignity of a Pontifical College, was built in 1963, and thus is this year celebrating the fiftieth anniversary of its founding.

As an opportunity to give thanks for the fifty year ministry of the Slovak Institute and College, His Eminence Cardinal Jozef Tomko, prefect emeritus of the Congregation for the Evangelization of Peoples, celebrated Mass with our group, along with the faculty and priest-students who reside at the Slovak College. Back in the 1960s, then Father Jozef Tomko, along with his collaborators, came to America, seeking the assistance of American Catholics of Slovak background, to assist in the endeavor of building a residence for Slovak seminarians and priests in the Eternal City. During the Communist era, this important building also served as a printery, producing religious materials to be sent secretly into Slovakia. Slovak Catholics in America responded generously to the invitation to assist in its development. The current edifice was constructed and opened in 1963. It seemed guite appropriate that Cardinal Tomko, who helped spearhead the campaign to build the Slovak College, would be the celebrant

(FOR APPLICANTS ENTERING RELIGIOUS LIFE) St. John Vianney Award

 St. Theresa of the Little Flower St. André Bessette, C.S.C.

\$300 ANNUALLY

The LPSCU is offering three separate Religious Awards for members entering Religious Life. They are:

The **St. John Vianney Award** is offered to any male member of the LPSCU aspiring to the priesthood. The member may apply for the \$300 award upon entrance into an approved program of priestly formation. The award may be renewed for each successive year until ordination, provided the member re-applies for said award.

R The St. Theresa of the Little Flower Award is offered to any female member of the LPSCU aspiring to religious life. The member may apply for the \$300 award upon completion of her first year of Novitiate. The award may be renewed annually until the member is professed as a religious nun, provided she re-applies for said award.

R The St. André Bessette Award is offered to a male member of the LPSCU aspiring to religious life as a Brother in a religious congregation. He may apply for the \$300 award upon entrance into an approved program for Religious Brother formation. The award may be renewed for each successive year until completion of the program, provided the member re-applies for said award.

Following are the Guidelines for applying for each of the Religious Awards. All applicants must:

- Be a member of the LPSCU for two (2) years with a minimum \$2,000 permanent reserve life insurance certificate (excludes term insurance).
- Provide a wallet-size color photo with the application.
- Re-apply each year while attending/completing studies for Religious Life (in order to receive the award each year of his/her religious training).

Applicants must meet all criteria outlined and provide data indicated to be eligible. Incomplete applications or those missing data requirements will not be considered. All materials become the property of the LPSCU and will not be returned.

Applications are available from the LPSCU Home Office or its website. Applications must be postmarked by August 31, 2013.

LPSCU Announces Three New Life Insurance Plans

Effective January 1, 2013, the LPSCU has implemented a 5 Payment Life Plan for ages 0 to 80; a 10 Payment Life Plan for ages 0 to 75; and a 15 Payment Life Plan for ages 0 to 70. Each plan allows for premium payments to be made monthly, quarterly, semiannually, or annually. The certificate becomes fully paid at the end of the specified Plan Year period, and coverage remains in full force and effect for the entire life of the insured without any additional premium payments required. Upon the death of the insured, the face amount of the certificate is paid to the insured's named beneficiary/ies.

A member with any of these plans is entitled to all fraternal benefits of the LPSCU including educational awards, youth and adult activities, newborn benefits, prescription discount card, official publication, and discount car rental.

Any of these plans is perfect for both youth and adults – and especially anyone who prefers to have their life insurance paid within 5, 10, or 15 years.

Cooking Corner

PEACHES AND CREAM CHEESECAKE

¾ cup flour3½ oz. pkg. dry vanilla1 tsp. baking powderpudding, (not instant)½ tsp. salt1 egg

3 tsp. margarine ½ cup milk 20 oz. can sliced peaches, drained (reserve juice)

Filling:

8 oz. cream cheese 3 Tbps. peach juice ½ cup sugar

Topping:

1 Tbsp. sugar ½ tsp. cinnamon

Combine flour, baking powder, salt, margarine, pudding, egg, and milk, and beat 2 minutes at medium speed. Pour into a greased 9" pie pan. Place the drained peaches over the batter. Combine

cream cheese, sugar, and peach juice; beat 2 minutes at medium speed, then spoon filling to within 1" of edge of batter. Combine sugar and cinnamon; sprinkle over cream cheese filling. Bake at 350 degrees for 30 to 35 minutes.


The ceremony was followed by a reception at Westlake Village Inn, Westlake Village, California.



Dear Junior Members,

On July 4, 1776, delegates to the Continental Congress gathered in Philadelphia's Independence Hall voted to accept the Declaration of Independence. On August 2 that same year, fifty-six of these brave men signed their names to this historic document, giving birth to a new nation as they declared their independence from Great Britain.

Have you ever wondered what happened to the fifty-six men who signed the Declaration of Independence? They willingly signed the document, all the while knowing that they were committing treason against the British Crown. If caught and

captured, they risked being imprisoned or put to death. These men valued freedom, liberty, equality, and prosperity for all to such an extent that they found this fate worth the risk.

What kind of men were they? They came from a wide cross-section of the population. Twenty-five were lawyers or jurists. Eleven were merchants. Nine were farmers or plantation owners. One was a teacher, one a musician, and one a printer. They were all well educated and men of means, and yet risked that very wealth to sign the Declaration of Independence. For not only could they lose their lives if captured by the British, but their homes, land, possessions, and money would be forfeit to the Crown.

Here is what happened to some of that brave fifty-six. Carter Braxton of Virginia, a wealthy planter and trader, saw his ships swept from the seas by the British Navy. He had to sell his home and property to pay his debts, and he died in poverty.

Thomas Nelson, Jr. saw his home occupied by the British General Cornwallis. Nelson's home was later destroyed and he was bankrupt when he died.

Thomas McKeam was so hounded by the British that he was forced to move his family constantly. He served in Congress without pay and his family was kept in hiding. His possessions were taken from him and poverty was his reward.

Vandals and enemy soldiers looted the properties of Bartlett, Ellery, Clymer, Hall, Gwinnet, Walton, Heward, Rutledge, and Middleton; the latter four were captured and imprisoned.

Francis Lewis had his home and properties destroyed. To punish him, the British jailed his wife, and she died within a few months.

After signing the Declaration, Richard Stockton, a Supreme Court Justice, rushed back to his estate in an effort to protect his wife and children. Although he and his family found refuge with friends, a British sympathizer betrayed him and Stockton was pulled from his bed and beaten by British soldiers. He was jailed and starved. When he was finally released, his home and all of his possessions destroyed, he and his family were forced to live on charity.

John Hart was forced to flee from his wife's bedside as she lay dying. Their thirteen children fled for their lives. His



fields and his gristmill were laid to waste. He lived in forests and caves, finally returning home to find his wife dead and his children vanished. A few weeks later, he died from exhaustion and a broken heart.

Lewis Morris and Philip Livingston suffered fates similar to Hart's.

John Hancock, one of the wealthiest men in New England, lost most of his fortune during the war and gave over \$100,000 to the cause of freedom.

Caesar Rodney, a Delaware statesman, was gravely ill with facial cancer. His only hope was to return to England for treatment, yet Rodney sealed his fate by signing the Declara-

tion of Independence. He was one of several who fulfilled their pledge with their lives.

In all, five of the fifty-six were captured by the British and tortured. Twelve had their homes ransacked, looted, confiscated by the enemy, or burned to the ground. Seventeen lost their fortunes. Two lost their sons in the Army; another had two sons taken prisoners of war. Nine of the fifty-six lost their lives in the war, from wounds or hardships inflicted by the British.

It is important to remember that despite the hardships they faced, not a single one of them defected or failed to honor his pledge. Would you be willing to do the same? Through the great price these founding fathers were willing to pay, this nation was born.

HOLIDAY INSTRUMENTS

We will soon celebrate the 4th of July, our nation's birthday. Will you join us?

To make a **Tambourine**, you'll need two aluminum pie plates. Turn one pie plate upside down on top of the other, lining up the edges. With an adult's help, staple the pie plates together around the rims. Punch four or five holes evenly spaced around the rim of the plates. Pull colorful ribbons through each hole. Before tying the ribbons, add a bell to each knot so your tambourine will make music when you shake it.

Maracas are Latin-American musical instruments made from gourds filled with dried seeds. To make your own, use plastic bottles shaped like gourds and paint bright designs on them. Put dried beans, dried peas, or seeds in the bottles and screw on the lid. When you turn them upside down and shake them in time to the music, they will make a nice sound.

Facts About Lady Liberty

The Statue of Liberty is a gift from France. It was unveiled in New York Harbor in 1886.

The statue's right arm and original torch crossed the Atlantic Ocean three times. They were originally shipped to the U.S. from France and put on display to raise money to finish the landmark. They were then returned to Paris to join the rest of Lady Liberty, which was then shipped back to America.

The Statue of Liberty weighs 225 tons, is more then 151 feet high, and stands on a 154-foot-high pedestal.

Each sandal is 25 feet long. This is equivalent to a size 879 shoe! A single fingernail measures 13×10 inches and weighs about $3\frac{1}{2}$ pounds.

This recipe makes 25 pops. You'll need:


4 egg whites 1 cup sugar

25 ice cream sticks

Multicolored edible decorating stars

Preheat oven to 200 degrees. Lightly coat two baking sheets with non-stick cooking spray. Using an electric mixer, beat egg whites at medium speed until frothy. Add sugar one tablespoon at a time, beating until stiff peaks form. (This will take about ten minutes.) Drop meringue by rounded tablespoons onto the baking sheets. Use a spoon to smooth peaks, but don't flatten. Insert craft sticks about ¼" into the bottom of each "cloud." Decorate tops with stars. Bake one hour, then turn off oven and leave pops in oven overnight.

These are great treats for birthday party giveaways. Use a permanent marker to write the name of each guest on the sticks before placing them into the meringue.

raised by the annual Saints Cyril and Methodius Appeal, coordinated by the Slovak Catholic Federation.

Before our time in Rome concluded, we had the privilege of celebrating Mass at the tomb of Saint Peter in the Basilica of Saint Peter in the Vatican and also in the Basilica of Saint Clement. Along with the remains of Pope Saint Clement, the mortal remains of Saint Cyril are also housed in this important basilica. Following the Mass at Saint Clement's, the group visited the excavations below the current-day basilica, which included a visit to the original tomb of Saint Cyril. The group also visited the Basilica of Saint Mary Major and viewed a special plaque which highlights the acceptance, by Pope Adrian, II, of the Divine Liturgy in the vernacular (Slavonic) that was developed by Saints Cyril and Methodius.

Following our time in the Eternal City, our group then journeyed to Slovakia, to participate in the celebration of the 1,150th anniversary of the arrival of the brother saints, Cyril and Methodius, in 863 A.D., to preach the Gospel to the Slavic peoples. In the Slovak Republic and the Czech Republic, this year is a special Jubilee Year to honor the ministry of the

brother saints. Our itinerary included visits to sites that are significant to the life and ministry of Saints Cyril and Methodius while they lived among the Slavic peoples.

Of special importance were liturgies celebrated in the Cathedral of Saint Emmeram, Nitra, where Methodius served as the first bishop; the Basilica of the Assumption of the Blessed Virgin Mary and Saints Cyril and Methodius, Velehrad, the Czech Republic, where it is believed that Saint Methodius died; and the Basilica of Our Lady of Sorrows, Šaštín, which is the national pilgrimage site for Western Slovakia. In Šaštín, His Excellency, the Most Reverend Jozef Halko, Auxiliary Bishop of Bratislava and the delegate of the Slovak Bishops Conference to Slovaks Living Abroad, celebrated Mass for the pilgrims and offered an explanation of a relief of Our Lady of Sorrows in the basilica. As his homily, Bishop Halko offered an English translation of the homily given by Blessed Pope John Paul II when he visited Šaštín in 1995.

As organizer of this special Pilgrimage, I hope that those who participated allowed the Holy Spirit to open the doors of their hearts wider to Christ and to grow in their willingness to be modern-day evangelizers, those who share the Gospel message in word and deed.

"O God, who enlightened the Slavic peoples through the brother Saints Cyril and Methodius, grant that our hearts may grasp the words of your teaching, and perfect us as a people of one accord in true faith and right confession. Through our Lord Jesus Christ, your Son, who lives and reigns with you in the unity of the Holy Spirit, one God, for ever and ever. Amen."
