This allowed for some sense of comfort as she didn't have to uproot her family and start over in a different, maybe even smaller home.

My grandfather's decision to purchase life insurance has given my grandmother peace of mind over the years, and has had a continuously positive effect in all four generations of our family.

# PROCLAMATION NATIONAL FLAG DAY -**TUESDAY, JUNE 14, 2016**

**Annual Pause for the Pledge of Allegiance** to the U.S. Flag

WHEREAS, by Act of Congress of the United States dated June 14, 1777, the first official flag of the United States was adopted, and WHEREAS, by Act of Congress dated August 3, 1949, June 14 of each year has been designated National Flag Day, and

WHEREAS, on De-



cember 8, 1982, the National Flag Day Foundation was charted to conduct educational programs and to encourage all Americans to Pause for the Pledge of Allegiance on National Flag Day, June 14, and

WHEREAS, by Act of Congress, Public Law 99-54 was passed to have the Pause for the Pledge of Allegiance as part of the celebration of National Flag Day throughout the nation, and

WHEREAS, National Flag Day celebrates our nation's symbol of unity, a democracy in a republic, and stands for our country's devotion to freedom, to the rule of law, and to equal rights for all.

NOW, THEREFORE, I, Theresa A. Kluchinski, National President, do hereby proclaim June 14, 2016, as National Flag Day and urge all members of the Ladies Pennsylvania Slovak Catholic Union to pause at 7 p.m. Eastern Time on this date for the 34th annual Pause for the Pledge of Allegiance to the United States Flag and our great nation.

# Cooking Corner

HAM AND NOODLE CASSEROLE

1/2 lb. 1/4-inch wide noodles,

cooked 4 Tbsp. butter

1 cup sour cream  $\frac{1}{2}$  cup grated cheese 2 slightly beaten eggs ½ tsp. salt

1 small onion, chopped fine 1½ cups finely chopped cooked ham

Cook noodles according to directions. Melt butter.

Cook onion until soft, not brown; remove from heat. Mix eggs and sour cream in a small bowl. Add mixture to onion, cheese, and ham; add salt. Combine mixture with noodles. Pour into buttered 2- quart casserole dish. Bake 45 minutes at 350 degrees.



# LPSCU 20 YEAR ENDOWMENT PLAN

- Provide a notice of acceptance or tuition receipt for the coming scholastic year.





Carnations have come to represent Mother's Day since its founder, Anna Jarvis, delivered 500 of them at the first Mother's Day celebration in 1908. Many religious services held later copied the custom of giving away carnations. This also started the custom of wearing

a carnation on Mother's Day. Anna Jarvis chose the carnation because it was the favorite flower of her mother. In part due to the shortage of white carnations, and in part due to the efforts to expand the sales of more types of flowers on Mother's Day, florists promoted wearing a red carnation if your mother was living, or a white one if she had died. This was tirelessly promoted until it made its way into the popular observations at churches.

On Father's Day, we give thanks to God for having the right to call them Dad, showering


them with gifts, love, and affection.

# Member James Yocum Has Civil War Ancestor

The 2015 Semi-annual Meeting of the Ladies Pennsylvania Slovak Catholic Union was held in Gettysburg, Pennsylvania. While attending, National Trustee James Yocum and daughter Gina Yocum, a member of Branch 39, were able to visit the Pennsylvania Memorial on the Battlefield in Gettysburg National Military Park. James and Gina are direct descendants

of Isaac Yocum, a member of Company C, 121st Pennsylvania Volunteer Infantry Regiment, 1st Brigade, 3rd Division, 1st Corps, Army of the Potomac. The 121st Pennsylvania Regiment served on the extreme left of the Union line on Seminary Ridge on day 1 of the battle of Gettysburg. On days 2 and 3, they held a position on Cemetery Ridge. Private Isaac Yocum served during the Civil War from the famed battle of Fredericksburg

until the war's end at Appomattox. He was present at all of the engagements during the battle of Gettysburg. His name can be found listed with all other Sons of Pennsylvania on the Pennsylvania Memorial located on the battlefield.

The 41st National Convention of the LPSCU will be held June 24-27, 2016, in Gettysburg. Delegates to the convention will attended Sunday Mass at Gettysburg's historic St. Francis Xavier Roman Catholic Church. The church served as a hospital and refuge for wounded Union and Confederate soldiers during and following the battle.
