We read in the Bible, "In the countryside close by there were shepherds out in the fields keeping guard over their sheep during the watches of the night. An angel of the Lord stood over them and the glory of the Lord shone round them. They were terrified, but the angel said, 'Do not be afraid. Look, I bring you news of great joy, a joy to be shared by the whole people. Today in the town of David a Savior has been born to you; He is Christ the Lord. And here is a sign for you: you will find a baby wrapped in swaddling clothes and lying in a manger.' Now it happened that when the angels had gone from them into heaven, the shepherds said to one another, 'Let us go to Bethlehem and see this event which the Lord has made known to us.' So they hurried away and found Mary and Joseph, and the baby lying in the manger. When they saw the child they repeated what they had been told about him, and everyone who heard it was astonished at what the shepherds said to them. As for Mary, she treasured all these things and pondered them in her heart. Indiana Branches Donate to Veterans' Cause

While attending the Indiana Fraternal Alliance Meeting in Kokomo, Indiana, August 23-24, 2018, Joan Hladek and Renee Hladek, LPSCU's delegates to the meeting, made LPSCU's contributions to the Alliance's sponsored charity for this meeting. The charity was Jefferson Street Commons, a facility that provides permanent, supportive housing (apartments) for chronically homeless veterans. This facility first provides a home and then surrounds the veterans with services that will help with their stabilization. LPSCU 10 Payment Life Plan

The Slovak Nativity

In Slovakia, Christmas trees are decorated as in most other places where Christmas is celebrated, but Slovaks traditionally use fruits, angel-shaped baked goods, candies and other sweets, and homemade wooden ornaments, besides the usual colored lights. The tree will not be taken down until Epiphany on January 6.


The nativity scene, called "Bethlehem," is placed beneath the Christmas tree. Distinctive nativity scenes and traditions have been created around the world and are displayed during the Christmas season in churches, homes, shopping malls and other venues, and occasionally on public lands and in public buildings.





There are two very special "Bethlehems" on permanent display in the world. These nativity scenes are carved from wood. Apart from Christ's birth in the town of Bethlehem, the carvings show the history of the Slovak nation. Bethlehem is incorporated into the scenery of the most important Slovak monuments. It depicts life, work habits, and traditional activities of the Slovak people (shepherds, miners, wine growers, loggers, craftsmen, potters, carpenters, and blacksmiths). The scene of Jesus' birth is situated in the middle of the pieces. There are also the dominant features of castles and cathedrals. In the background is Mount Kriváň, one of the Tatra peaks and a symbol of Slovak nationality.

The Slovak Animated Wood Carving, which is on display at the National Slovak Society Heritage Museum in McMurray, Pennsylvania, is a masterpiece by Jozef Pekara, Vlado Tomko, and Miloš Karabin, carvers native to Rajecké Teplice. It took the skilled masters two and a half years to create the carving. The piece of work is $3\frac{1}{2}$ feet wide, 6 feet deep, and 8 feet high.



Put seeing one of these wonders on your bucket list!

The other Slovak Animated Wood Carving is on display in Rajecká Lesná, Slovakia. Jozef Pekar carved the entire masterpiece himself. The piece of work is 8 feet wide, 28 feet long, and 10 feet high. This Slovak Bethlehem was opened and blessed on Sunday, November 26, 1995.


