#### \$300 ANNUALLY

The LPSCU is offering three separate Religious Awards for members entering religious life. They are:

#### The St. John Vianney Award

This award is offered to any male member of the LPSCU aspiring to the priesthood. The member may apply for the \$300 Award upon entrance into an approved program of priestly formation. The award may be renewed for each successive year until ordination, provided the member re-applies for said award each year.

#### \* The St. Theresa of the Little Flower Award

This award is offered to any female member of the LPSCU aspiring to religious life. The member may apply for the \$300 award upon completion of her first year of Novitiate. The award may be renewed annually until the member is professed as a religious nun, provided she re-applies for said award each year.

#### The St. André Bessette Award

This award is offered to a male member of the LPSCU aspiring to religious life as a brother in a religious congregation. He may apply for the \$300 award upon entrance into an approved program for religious brother formation. The award may be renewed annually for each successive year until completion of the program, provided the member re-applies for said award each year.

#### Following are the guidelines for applying for each of the Religious Awards. All applicants must:

- Be a member of the LPSCU for two (2) years with a minimum \$2,000 permanent reserve life insurance certificate (excludes term insurance).
- Provide a wallet-size color photo with the application.
- Re-apply each year while attending/completing studies for Religious Life in order to receive the award each year of his/her religious training.

Applicants must meet all criteria outlined and provide data indicated to be eligible. Incomplete applications or those missing data requirements will not be considered. All materials become the property of the LPSCU and will not be returned.

Applications are available from the LPSCU Home Office or its website. **Applications for the 2017 awards must be postmarked by August 31, 2017.**

# Sister Teresa Urda, SS.C.M.

Sister Teresa Urda (Sister M. Jonathan), SS.C.M., died at Maria Hall in Danville, Pennsylvania, on Sunday, April 2, 2017. Born in Torrington, Connecticut, on October 15, 1942, she was one of five children born to Andrew and Helen (Vasko) Urda. She attended Sacred Heart School in Torrington and her junior year at Torrington High School. Her three other high

school years were spent at St. Cyril Academy, Danville, from which she graduated in 1960.

Sister Teresa entered the Sisters of Saints Cyril and Methodius in Danville on September 8, 1961, and was received as a novice on August 13, 1962. She made her first profession of vows on August 13, 1964.

Sister Teresa taught seventh grade at Blessed Sacrament School in Charleston, South Carolina, eighth grade at Holy Name School in Stratford, Connecticut, and St. Francis of Assisi School in Torrington. Sister taught English at Pius X High School, Pottstown, Pennsylvania; English and Psychology at Andrean High School, Merrillville, Indiana; and English at Lebanon Catholic High School, Lebanon, Pennsylvania. During her years in secondary education she served as moderator of the yearbook, the Mission Club, the Student Council, and the sophomore and junior classes.

For eleven years, Sister Teresa was Director of Maintenance at the Motherhouse of the Sisters of Saints Cyril and Methodius. She was particularly interested in environmental concerns. She was a volunteer at the House of Care at Geisinger Medical Center, Danville, for many years. Sister Teresa had a gift for writing and editing. Each week she sent out *The Focus*, which apprised the Sisters of the Congregation's activities and achievements. She handled the publicity for the activities of the St. Cyril Spiritual Center, one of the congregation's ministries located in Danville. As moderator of the St. Cyril Academy Alumnae Association, she compiled news for *The Challenge*, the organization's newsletter. Her most important achievement was writing the history of the first hundred years of the Sisters of Saints Cyril and Methodius.

Sister Teresa is survived by a sister, Mrs. Helen Borkowski, Harwinton, Connecticut; a brother, Cyril Urda of Torrington; and several nieces and nephews.

Transferal and recitation of the Rosary took place on April 7 at Maria Hall followed by a Wake Service. A Mass of Christian Burial was celebrated at Maria Hall by Maria Hall chaplain, Reverend Gerard Heintzelman, with concelebrant Reverend Patrick Devine. Burial was in the Sisters' cemetery.

Sister Maria Isidore (Agnes Tomascak), 89, died on May 9, 2017, at Emmanuel Center, Danville, Pennsylvania. Born on April 17, 1928, in New Milford, Connecticut, she was the daughter of Andrew and Veronica (Piskura) Tomascak, and was the eldest of their 14 children.

Cyril and Methodius Catholic School in Bridgeport, Connecticut, and in 1947 graduated from St. Cyril Academy, Danville, Pennsylvania.

On February 1, 1948, she entered the Sisters of Saints Cyril and Methodius, was received as a novice on August 11 of that year, and made her first profession of vows on August 10, 1950.

During her entire religious life, Sister Maria Isidore lived at the Motherhouse complex in Danville, where she was involved in horticulture. From 1950 until recently she engaged in the cultivation of vegetables and flowers, and cared for the vineyard and the fruit trees, pruning the apple, peach, plum, and pear trees in early spring and gathering the ripe fruit in the fall. Sister Isidore spent a lifetime loving the earth, its plants, its creatures, and its possibilities. Under her care, the Motherhouse gardens produced an abundance of flowers, vegetables, and fruit.

Sister Maria Isidore was preceded in death by her parents and two brothers William and Methodius. She is survived by six brothers, Andrew and James of Southbury, Connecticut, Albert of New Milford, Peter of Bradenton, Florida, Cyril of Bradenton and New Milford, and Robert of Port Charlotte, Florida, and five sisters, Margaret DeLuca of Boynton, Florida, Barbara Carmignani of Danbury, Connecticut, Marion White of Bristol, Connecticut, Cecilia Hungerford of New Milford, and Christina Richards of Woodbury, Connecticut, and many nieces and nephews.

Transferal and recitation of the Rosary took place on May 17 at Maria Hall in Danville followed by a Wake Service. A Mass of Christian Burial was celebrated at Maria Hall by Maria Hall chaplain Reverend Gerard Heintzelman, with concelebrant Reverend Adam Keltos, OSB (Sister Isidore's cousin). Burial was in the Sisters' cemetery.



# **LPSCU 10 Payment Life Plan**

The LPSCU offers an economic and beneficial 10 Payment Life Insurance Plan for anyone from age 0 to 75. Under this plan, there is a minimum purchase requirement of life insurance. For those ages 0 to 70, the minimum purchase amount is \$5,000; for ages 71 to 75, the minimum purchase amount is \$2,000. Premiums are payable for ten (10) years from issue date. Upon the death of the insured, the face amount of the certificate is paid to the insured's named beneficiary/ies.

A member with a 10 Payment Life Plan is entitled to all

fraternal benefits of the LPSCU including educational awards, youth and adult activities, newborn benefits, prescription discount card, official publication, and discount car rental.

The 10 Payment Life Plan is perfect for both youth and adults – especially anyone who prefers to have their life insurance paid within ten (10) years.

During these unstable economic times, the 10 Payment Life Plan offered by the LPSCU is economical and beneficial for estate planning and can especially help with the high cost of funeral expenses.

To apply for this specific plan, or any other insurance plan offered by the LPSCU, contact your Branch Secretary or the LPSCU Home Office.

# LPSCU 2017 POST GRADUATE AWARD

The LPSCU has revised its Post-Graduate Award Benefit to our members who have received a Master's or Doctorate degree during the period from September 1, 2016 to August 31, 2017. Members who qualify may receive this award one time upon receiving their Master's degree <u>and</u> one time upon receiving their Doctorate. (Members must apply separately and provide all the required criteria to be eligible to receive both the Master's and Doctorate Post Graduate awards.)

Following are the guidelines for applying for the 2017 Post Graduate Award. All applicants must:

- Be a member of the LPSCU for at least five (5) years with a minimum \$2,000 permanent reserve life insurance certificate (excludes term insurance) for a \$300 Post Graduate Award **OR**
- Be a member of the LPSCU for at least five (5) years with a minimum \$5,000 permanent reserve life insurance certificate (excludes term insurance) for a \$500 Post Graduate Award.
- Provide a photocopy of the Master's or Doctorate degree received.
- Provide documentation that the degree was awarded between September 1, 2016 and August 31, 2017.
- Provide a wallet-size color photo.

Applicants must meet all criteria outlined and provide data indicated in order to be eligible. Applications missing data or with incomplete requirements will not be considered. All materials become the property of the LPSCU and will not be returned.

# **BOOK BUY PROGRAM**

The LPSCU Book Buy Program assists our members who are attending college by reimbursing 15% of their college book expenses. This award is available *in addition* to any other educational award members may have received from the LPSCU.



How to qualify? You need only to purchase a **new 20 Payment Life or Whole Life Policy** during the student's freshman, sophomore, junior, or senior years of college. Premiums must be paid on an annual, semiannual, or quarterly basis and must be current in order for the student member to be eligible for this program. **Student members can submit an LPSCU Educational Book Buy Program Application each school year and receive a 15% refund based on books purchased (limited to the amount paid for the annual premium on the 20 Payment Life or Whole Life Policy).**

# LPSCU Matching Fund Program

On January 2, 2011, the LPSCU initiated a Matching Fund Program for our Branches and Districts. In the program's initial year, we had one Matching Fund project.

As a fraternal benefit society, the LPSCU encourages our Branches and Districts to participate in a Matching Fund project for the benefit of a charitable organization. The funds that are raised from a matching fund event will be matched dollar for dollar by the LPSCU, up to a maximum of \$100 for a Branch event and \$200 for a District event. If a Branch or District prefers to make a donation to a charitable organization, that can be considered as a Matching Fund project except that the donation will be limited to 50% of the maximum amount, \$50 for a Branch and \$100 for a District. Each Branch and District is allowed two Matching Fund events per year.

# July 4 – Independence Day

In the United States, Independence Day - better known as the Fourth of July - is a federal holiday commemorating the adoption of the Declaration of Independence on July 4, 1776, declaring independence from the Kingdom of Great Britain. Independence Day is commonly associated with fireworks, parades, barbecues, carnivals, picnics, concerts, baseball games, political speeches, ceremonies, and various other public and private events celebrating the history, government, and traditions of the United States.

On July 4, 1777, thirteen guns were fired, once in the morning and again as evening fell, in Bristol, Rhode Island. Philadelphia celebrated the first anniversary in a manner a modern American would find quite familiar: an official dinner for the Continental Congress, toasts, 13-gun salutes, speeches, prayers, music, parades, troop reviews, and fireworks. Ships were decked with red, white, and blue bunting.

In 1791, the first recorded use of the name "Independence Day" occurred.

In 1870, the U.S. Congress made Independence Day an unpaid holiday for federal employees. In 1931, Congress changed Independence Day to a paid federal holiday.

The residents of Vicksburg, Mississippi, celebrated Independence Day for the first time since July 4, 1863, when the Siege of Vicksburg ended with a Union victory during the American Civil War.

# Východná Folk Festival — June 29-July 2, 2017

The folk festival "Východná" is the oldest and largest festival in Slovakia. More than 1,400 performers participate in this festival each year. Craftsmen and artists are also a very important part of this festival on the grounds outside the large, open-air theater. In recent years, interactive programs such as dance, music, singing, and craft workshops have been added for children. The festival significantly contributes to



the revival, preservation, and development of the creative and public presentation of the values of the precious Slovak cultural treasures. The festival takes place annually, usually during the first weekend in July in the village of Východná, near the High and Low Tatras.
