## ALL MEMBERS ASPIRING FOR LPSCU NATIONAL OFFICE

According to the Official Minutes of the Board of Directors' Semiannual Meeting held in Gettysburg, Pennsylvania, on September 18-19, 2015, it is required that any member with aspirations for National Office must request an Intent Form from the Home Office. According to the LPSCU Bylaws, the qualifications for candidates are set forth in Article III:

<u>Section 2</u>. A candidate for office must be at least 21 years of age, an active member, and be present as a delegate at the National Convention.

<u>Section 3</u>. No two immediate family members can serve as an Officer of the LPSCU during the same term of office. Immediate family is defined as: grandparent, parent, spouse, or sibling.

<u>Section 4</u>. A member or delegate who is a National Officer/Director/Board Member of another fraternal benefit society may not hold office of the LPSCU.

<u>Section 10</u>. No hired employee of the LPSCU shall be eligible to hold any National Office in the LPSCU while so employed, with the exception of the office of Secretary-Treasurer.

Section 11. Since the position of President is full time, working out of the Home Office, nominations for this position will not be made from the floor. Nominations for this position are by written application, stating the nominee's qualifications, personal background, and history. Applications must be submitted to the Home Office two months prior to the National Convention. The National Board of Directors will verify these qualifications by use of personal interviews, a professional investigating company, or any other means. From these applications, the National Board of Directors shall recommend to the Nominating Committee candidates qualifying for the position of President. In the event the National Board of Directors cannot recommend a qualified candidate to the Nominating Committee, a search committee will be appointed by the National Convention to fill the vacancy.

Section 12. While nominations from the floor are to be accepted for all National Offices, excluding the position of President and the hired position of Secretary-Treasurer, upon acceptance of the nomination, nominee will provide a resume to the delegates of the National Convention, containing personal background, history, and past experience to prove their qualifications for the office to which they have been nominated.

Because the coronavirus pandemic has forced the postponement of our Convention, originally scheduled for June, we are extending the deadlines for submitting Intent Forms. Completed Officer Intent Forms must now be returned to the Home Office with a postmark no later than August 15, 2020, with the exception of the Intent Form for the position of President, which is to be returned to the Home Office with a postmark no later than July 15, 2020.


## Rev. Dianiska District to Hold Matching Fund Event

Members of the Rev. Dianiska District will hold a Special Gifts Raffle at their Christmas party on Sunday, December 6, 2020. The event will be held in conjunction with the LPSCU's Matching Fund Program and will benefit the Matthew Mursch, Jr. Foundation.

Matthew Mursch, Jr., son of Lynn and Matthew Mursch of Scranton, Pennsylvania, was born in 2011 with a congenital heart defect called Hypoplastic Left Heart Syndrome. Essentially this means he was born with half a heart. Matthew has undergone three reconstructive open heart surgeries ranging from 5 days old to  $2\frac{1}{2}$  years old. He has undergone over a dozen cardiac catheterizations and multiple procedures. He spent the first three years of his life in and out of inpatient care at The Children's Hospital of Philadelphia (CHOP) and will continue to need cardiac care throughout his life.

In February 2020, Matthew was diagnosed with yet another rare disorder, ALPS (Autoimmune Lymphoproliferative Syndrome). ALPS is a disorder in which the body cannot properly regulate the number of immune system cells (lymphocytes) it produces. Accumulation of excess lymphocytes results in enlargement of the lymph nodes. This can turn into Lymphoma. Matthew has had to stop attending school in order to get his immune system back in order. He is currently taking an oral chemotherapy medication to help raise his blood levels. He makes weekly trips to the lab at home and bi-weekly trips to CHOP.

The LPSCU is offering three separate Religious Awards for members entering religious life. They are:

#### \* The St. John Vianney Award

This award is offered to any male member of the LPSCU aspiring to the priesthood. The member may apply for the \$300 Award upon entrance into an approved program of priestly formation. The award may be renewed for each successive year until ordination, provided the member re-applies for said award each year.

# The St. Theresa of the Little Flower Award This award is offered to any female member of the LPSCU aspiring to religious life. The member may apply for the \$300 award upon completion of her first year of Novitiate. The award may be renewed annually until the member is professed as a religious nun, provided she

#### The St. André Bessette Award

re-applies for said award each year.

This award is offered to a male member of the LPSCU aspiring to religious life as a brother in a religious congregation. He may apply for the \$300 award upon entrance into an approved program for religious brother formation. The award may be renewed annually for each successive year until completion of the program, provided the member re-applies for said award each year.

## Following are the guidelines for applying for each of the Religious Awards. All applicants must:

- \* Be a member of the LPSCU for two (2) years with a minimum \$2,000 permanent reserve life insurance certificate (excludes term insurance).
- Provide a wallet-size color photo with the application.
- Re-apply each year while attending/completing studies for Religious Life in order to receive the award each year of his/her religious training.

Applicants must meet all criteria outlined and provide data indicated to be eligible. Incomplete applications or those missing data requirements will not be considered. All materials become the property of the LPSCU and will not be returned.

Applications are available from the LPSCU Home Office or its website. **Applications for the 2020 awards must be postmarked by August 31, 2020.**

## Cooking Corner

#### SEA SHELL PASTA SALAD

#### Pasta Mixture

1 box small pasta shells, cooked and drained

2 cucumbers, diced

2 small green peppers, diced

1 small onion, diced

1 small jar red pimentos, diced

#### **Dressing**

<sup>1</sup>/<sub>3</sub> cup vegetable oil

34 cup sugar

34 cup vinegar

1 can tomato soup

Combine pasta ingredients in a large bowl. Sepa-

rately, mix dressing ingredients together well. Add dressing mixture to pasta and mix well again. Make a day ahead so the flavor can permeate the salad. Store in refrigerator. You can add more or less cucumbers, peppers, onion, and pimentos to suit what your taste buds enjoy.



### LDSCU 20 YEAR ENDOWMENT PLAN

A unique way to generate sizable funds for the purpose of future college education costs for young family members is through a 20 Year Endowment Life Insurance Plan. 

## Pitt Offers Virtual SLI Courses

Due to ongoing restrictions caused by the coronavirus, the University of Pittsburgh's Summer Language Institute (SLI) has announced that its usual SLI summer program that included four weeks of study in Bratislava, Slovakia, has been changed to "Virtual SLI." Although remotely delivered language instruction will be new to many students, the University is confident that SLI 2020 will be an interactive, vigorous, and fun program that is up to the standards of the traditional SLI.

SLI accepts undergraduates, graduates, and high-motivated non-affiliated learners. Since the program will be conducted completely online, Virtual SLI allows for participation by individuals who previously were unable to attend classes on campus. Partial scholarships are available and it is highly recommended that if you are interested in this program, you apply as soon as possible and no later than May 29, 2020 for consideration both into the program and for any scholarship monies.

Slovak classes will begin June 29, 2020, and will take place face-to-face via Zoom on Monday through Friday from 11:00 a.m. until 4:30 p.m. EST. Students will have lessons in conversational speaking, reading, listening, grammar, writing, and presentational speaking. There will be times when students are working independently on assignments and assessments, but most of the time will be spent interacting with the instructor and other students.

#### Mother's Day Chocolate Bouquet

- Chocolate DOVE PROMISES in assorted flavors
- green paint
- bamboo skewers
- scissors
- colorful cardstock
- double-sided tape
- hot glue gun
- floral arranging foam
- vase (preferably opaque)

Start by painting the bamboo skewers green.

Cut some flower shapes out of colorful, heavy cardstock. You really do need to use sturdy cardstock for this project, because these paper flowers are going to provide the support for the chocolate petals.

Trace around a flower cookie cutter. You can easily free-hand the flower or find some free clip art to use as a template.

Cut out the cardstock flowers

Glue the bamboo sticks to the back of the flowers.

Apply double-sided tape to the paper flowers, and then simply stick your chocolate petals right on!

Once the flowers have been made, trim a piece of floral foam to fit inside a vase . Stick the flowers in the foam and add a few cardstock leaves, if you'd like.



President Calvin Coolidge tried again in 1924, but the day still didn't become a holiday. The main reason was because many people felt that the day was too commercial. That the only reason to have the holiday was so that companies who sold ties and men's clothing could make money.

In 1966 President Lyndon Johnson proclaimed the third Sunday of June as Father's Day. The national holiday was finally signed into law in 1972 by President Richard Nixon. Since then the day has become a major holiday in the United States.

### St. John's Day ~ June 24


