

LABOR DAY

The Catholic Church has always taught the dignity, meaning and redemptive value of all human work. It further expressed the calling of everyone to work in some way to contribute to the common good of all.

"Human work proceeds directly from persons created in the image of God and called to prolong the work of creation by subduing the earth, both with

and for one another. Hence work is a duty: 'If anyone will not work, let him not eat.' Work honors the Creator's gifts and the talents received from him. It can also be redemptive." (Catholic Catechism of the Church, paragraph 2427)

Also, in his Letter on the Gospel of Work, Pope St. John Paul II wrote, "The evangelization of the working world entails fidelity and honesty in carrying out one's professional service, moral consistency in lesser and greater decisions, and fraternal solidarity towards those in need. It also requires the witness, wherever possible and appropriate, to one's Christian identity, so that the message of Jesus Christ, the one Savior, may be offered in every workplace as a gift and grace of inner renewal and a force for social change. Indeed, the Son of God 'worked with human hands, he thought with a human mind. He acted with a human will, and with a human heart he loved.' Whoever believes in him and follows him finds the light and strength to be salt and leaven in every situation and circumstance."

This Labor Day, take some time to personally reflect on the importance of work, the value of work, and the recognition and respect of all workers.

God, in your goodness, you have made a home for the worker. Make a place in our hearts for compassion to all the men and women who labor tirelessly for basic necessities.

Be with us, Christ Jesus, as we go about the busyness of our work. May we continue to work together to bring about your reign.



Cooking Corner FESTIVE COFFEE PUMPKIN PUNCH

3 c. milk

Cinnamon sugar

8 oz. canned sweetened pumpkin puree (not the cooked mashed sweet pumpkin) ½ tsp. ground cinnamon 2 c. fresh brewed coffee Whipped cream or Cool Whip



In a saucepan, heat the milk, pumpkin, and cinnamon on low heat, whisking constantly. The mixture should just reach a boil. Transfer to a bowl or individual cups and stir in the coffee. When serving in cups, top with a spoonful of whipped cream or Cool Whip and a dusting of cinnamon sugar. Makes approximately six servings.



LPSCU 2024 POST GRADUATE AWARD

The LPSCU is offering a Post Graduate Award Benefit to our members who are awarded a Master's or Doctorate degree during the period running from July 1, 2023, to August 30, 2024. Applicants must have a minimum of \$5,000 of insurance through the LPSCU in order to apply for the \$500 award. Applicants can increase their current face amount to meet the \$5,000 requirement.

Members who qualify may receive this award one time upon receiving their Master's degree and one time upon receiving their Doctorate. (Members must apply separately and provide all the required criteria if they wish to apply for both the Master's and Doctorate Post Graduate Awards.)

Following are the guidelines for applying for the Post Graduate Award. All applicants must:

- Be a member of the LPSCU for at least five years with a \$5,000 permanent reserve life insurance certificate. (Term insurance is excluded.)
- Provide a photocopy of the Master's and/or Doctorate degree received.
- Provide documentation that the degree was awarded between July 1, 2023 and August 30, 2024.
- Provide a wallet-size or digital color photo.

Applicants must meet all criteria outlined and provide data indicated in order to be eligible. Applications missing data or with incomplete requirements will not be considered. All materials become the property of the LPSCU and will not be returned.

Pittsburgh Slovakians Keep Traditions Alive

If you ever have the opportunity to see the Pittsburgh Slovakians perform, you are in for a real treat. The group – approximately twenty-five strong – takes command of the floor the minute the first musical note is heard. From the singing to the intricate dance routines and authentic costumes, the show is truly top-notch.

The group was founded in 1956 by Roman Niznik. Susan and Rudy Ondrejco took over direction after Roman's untimely passing in 1977. In winter of 1991, Susan and Rudy formed a younger ensemble with the official organization of the Junior Pittsburgh Slovakians. The Slovakians take great pride in performing traditional Slovak songs and spreading their Slovak heritage throughout the Pittsburgh area and beyond.

The Pittsburgh Slovakians perform annually at Slovak Day at Kennywood Park and at the Slovak Heritage Festival at the University of Pittsburgh. They also provide entertainment at numerous festivals, conventions, and social events in and around the Pittsburgh area. They even enjoyed opportunities to perform on tours of Slovakia in 1989 and 1997. The group is unique in that there are no age restrictions, so there are three generations of performers ranging from age 4 to 60+.

SS.C.M. Appeal in Final Months

The Saints Cyril and Methodius Appeal is in its 46th year of raising money to assist the Pontifical Slovak College of Saints Cyril and Methodius in Rome with its day-to-day operations. The Appeal relies upon the generosity of individual donors in addition to collections taken up in individual parishes of Slovak ancestry. LPSCU 20 YEAR ENDOWMENT PLAN

A unique way to generate significant funds for the purpose of future college education costs for young family members is to purchase a 20 Year Endowment Life Insurance Plan. Premium payments are made for a period of 20 years and will help defray higher education tuition and costs. Planning for college education tuition and costs should be started as soon as a child is born in order that the necessary resources be available for the child to pursue a college degree. An endowment life insurance certificate can serve many other purposes as well, such as assisting with wedding expenses or towards the purchase of a home, furniture, car, or a vacation.

After 20 years of premium payments, the insured will have the choice of any one of the following three options: (I) Immediate payment of the face value; (2) Immediate payment of a portion of the face value and a paid-up certificate for the face amount of the existing certificate (Option A); or (3) Paid-up certificate for a larger face value (Option B). In the event of death prior to 20 years, the face amount of the endowment certificate is payable

to the named beneficiary/ies.

The 20 Year Endowment Life Insurance Plan is offered from age 0 to 70 and premium payments can be made either monthly, quarterly, semi-annually, or annually. This plan offers the added fraternal benefits of educational awards, youth and adult activities, newborn benefit, prescription discount card, official publication, and discount car rental, to name a few.

A 20 Year Endowment Life Insurance Plan should be considered as a way to build up savings for the future, while at the same time protecting the insured with life insurance. To apply for this specific plan, or any other insurance plan offered by the LPSCU, contact your Branch Secretary or the LPSCU Home Office.

Life Insurance Awareness Month

Fire Prevention Month

October is officially designated as Fire Prevention Month. In light of the horrific wildfires that have taken place all over the world, most recently in Jasper, Alberta, and in the American West, I felt fire prevention was an important topic to highlight for October, focusing particularly on wildfires.

Obviously, the massive number of acres destroyed has forever changed the landscape in these locations. The absolute scorching of the earth is awful in itself, but it's the loss of life – both human and animal – as a result of these fires that is even more heart wrenching.

Last year, there were over 43,899 forest fires that burned more than 2,332,108 acres! There were 97 confirmed deaths from a devastating fire in Lahaina on Maui, Hawaii. Wildfires in Canada caused six deaths and destroyed precious ecosystems. I think all of us experienced the smoke and haze that blanketed much of the United States last year. If we could see the haze and smell the smoke from thousands of miles away, imagine the intensity to those living near the actual fires. Though some are caused by lightning strikes, the truly sad statistic is that 85-90% of wildfires occur because of human involvement, either intentionally or unintentionally.

So, how do you prevent fires, and in particular wild-fires? Humans cause nearly 90% of wildfires in the United States via carelessly discarded cigarettes, unattended campfires, burning debris, or through equipment malfunctions. Someone starts out burning trash in their back yard, a spark flies to dry, dead grass and before you know it, a full-blown wildfire has started and is engulfing acres in its wake.

Pay attention to the information given through your local media on whether it's okay to burn refuse and branches in your yard or whether there's a burn ban in effect in your area. Some fire companies near me even have outdoor signs that visually alert people what the danger index is for fires. It can range from green (It's okay to burn trash) all the way to red (Don't burn anything). This provides a quick visual to people traveling on the road. Note, too, that some municipalities don't allow open burning no matter what the conditions. Don't be someone who contributes to this problem by ignoring the rules and warnings.

Be smart. Be aware. As Smokey Bear says: *Only YOU Can Prevent Wildfires!*

The purpose of these monthly awareness articles is to bring to the forefront issues that people deal with every day but probably don't think about on a daily basis. The better informed we are, the better we can react to situations when needed.

Dožinky

Dožinky is a Slovak harvest festival. In pre-Christian times, the feast was usually celebrated on the autumn equinox. In modern times it is usually celebrated on one of the Sundays following the end of the harvest season.

While there are many regional varieties and traditions, most have some aspects in common. Often the peasants or farmers celebrating dožinky gather in the fields outside their village, form a procession and bring back a sheaf or the last batch of cereal reaped from nearby fields. The women would then turn it into a wreath and offer it to the guest of honor (usually the organizer of the celebration: a local noble, the richest farmer in the village or - in modern times - the representative of the authorities).



The wreath is a central feature of most celebrations associated with dožinky, as it symbolizes a rich harvest, the prospect of wealth and the power of new life vested in the grain gathered during the summer.



International Sudoku Day

Every year on September 9, puzzle enthusiasts around the world celebrate International Sudoku Day. This special day encourages people to enjoy the mental challenge and cognitive benefits of solving Sudoku puzzles.

International Sudoku Day was established in 2013 by the World Puzzle Federation to commemorate the birthday of Howard Garns, the American architect who is credited with creating the modern Sudoku puzzle.

St. John Paul II Feast Day ~ October 22



The Vatican Congregation for Divine Worship has approved of the optional memorial of St. John Paul II in the United States for October 22.

Pope John Paul II was head of the Catholic Church and sovereign of the Vatican City State from 1978 until his death in 2005.

In his youth, Wojtyła dabbled in stage acting. He graduated with excellent grades from an all-boys high school in Wadowice, Poland, in 1938, soon after which World War II broke out. During the war, to avoid being kidnapped and sent off to a German forced labor camp, he

signed up for work in harsh conditions in a quarry. Wojtyła eventually took up acting and developed a love for the profession and performed at a local theatre.

He decided to study theology and become a priest. Eventually, Wojtyła rose to the position of Archbishop of Kraków and then a cardinal. Wojtyła was elected pope on the third day of the second papal conclave of 1978, and became one of the youngest popes in history. The conclave was called after the death of John Paul I, who served only 33 days as pope. Karol Wojtyła adopted the name of his predecessor in tribute to him. John Paul II was the first non-Italian pope since Adrian VI in the 16th century, as well as the third-longest-serving pope in history after Pius IX and St. Peter.

The announcement of Pope John Paul II's canonization came after the Vatican revealed that two miracles were attributed to the late pope. After a dying French nun, Sister Marie Simon-Pierre Normand, prayed to Pope John Paul II during her battle with Parkinson's disease—the same illness that killed the pope—she was cured. The second miracle involved a 50-year-old woman, who claimed that she was cured of a brain aneurysm after a photograph of Pope John Paul II spoke to her. Pope John Paul II was canonized on April 27, 2014.


